## PINE-STRAWBERRY WATER IMPROVEMENT DISTRICT

The Pine-Strawberry Water Improvement District (PSWID) is seeking Statement of Qualifications from experienced contractors to provide Waterline Replacement and Water Facilities Improvement Project Construction Work, and related services, on an as-needed basis at various project locations throughout the PSWID utilizing Job Order Contracting (JOC) project delivery method.

It is the intent of the PSWID to select up to five (5) contractors for contract award. The initial term of the JOC will be for a minimum of one (1) year and may be renewed up to four (4) additional one-year terms. Renewal of the contract will be based on the successful performance of the JOC Contractor and the needs of the PSWID. It is PSWID's intent to enter into a cost plus fee structure.

During the term of the JOC, work is performed as a series of individual job orders. Individual projects may require the expenditure approval of the PSWID Board, or their designee. Each job order, initiated by the owner, is defined cooperatively by the owner and contractor. A scope, schedule and price are negotiated and agreed upon. The contractor is then directed to proceed with the work. Job Order Contracting may include ancillary planning and design services, pre-construction services, construction work, maintenance and as-built/record documentation to comply with Water Infrastructure Finance Authority, (WIFA) loan requirements and other relevant regulatory agency requirements.

Sealed proposals will be received by the PSWID, in the District Office located at 6306 W. Hardscrabble Road, Pine, AZ 85544 until 2:00 P.M. (AZ Time), July 17, 2018 for Waterline Replacement and Water Facilities Improvement Project Construction Work. No submittals will be accepted after 2:00 P.M on July 17, 2018. The submittals will be publicly opened and read aloud after 2:00 P.M., Arizona time, at the location and date listed above. All submittals shall be made on the REQUEST FOR STATEMENT OF QUALIFICATIONS JOB ORDER CONTRACTING WORK forms included in the Project and Contract Documents and shall include all applicable taxes.

This projects are funded with both PSWID funds and with Water Infrastructure Finance Authority (WIFA) loan funds. Davis-Bacon Wage Requirements, American Iron and Steel Certification and all WIFA requirements will apply to WIFA loan funded projects.

Contractors are invited to be present at the opening of bids but absence will not be considered cause for disqualification.

Contractors shall be responsible for any licenses or permits required by the regulatory agency of the State of Arizona that apply to the performance of this contract.

The PSWID reserves the right to reject any or all submittals, or to accept any submittals, or to waive any informality in any submittals, or to withhold the award if deemed in the best interest of the District.
