1. CALL TO ORDER

Trent McNeeley called the meeting to order at 5:33 p.m.

6. DISCUSS AND TAKE POSSIBLE ACTION RELATED TO REPLACEMENT OF THE OFFICE COPIER CONTRACT. Requested by Maher Hazine. Maher started the presentation, but the phone connection with him was lost. Karen finished the presentation with the information on the bids given by Valley Imaging Solutions and Arizona Office Technologies. The old printer is 5 or six years old. It only copies and scans in black and white. PSWID has to buy both the paper and toner for it and there is no service contract to cover repairs. The new printer will copy/scan/fax in black and white or color and it can also replace all of the printers in the

office. Toner and maintenance will be included in either contract. There is a \$2200 buyout to break the current contract. Valley Imaging Solutions which holds the current contract will reduce the buyout to \$1500 and split the cost of the buyout with the district. Arizona Office Technologies will not reduce the buyout cost and will just store the used printer. Valley Imagining Solutions is located in Payson and will be able to service the printer faster than Arizona Office Technologies which is located in Prescott. The cost of the contract with Valley Imaging Solutions will be \$201.60 per month for a 60 month lease. The cost of the contract with Arizona Office Technologies will be \$195.01 per month. Both companies will charge .008 cents per b/w copy and .05 cents for color copies. Since Valley Imaging Solutions is willing to split the cost of the buyout, it is recommended that we sign the new contract with them. Tom Weeks moved to accept the contract with Valley Imaging Solutions and issue them a check for \$750 for PSWID's share of the buyout. Larry Bagshaw seconded the motion. The motion carried unanimously.
