The projects listed in red total \$5,159,174.

The District continues to interview the Three (3) On Call Engineering firms to determine which of the pipeline replacement projects they will be selected to design.

Sunrise Engineering and Painted Sky Engineering have provided a draft of the EJCDC engineering contract form for review.

The District has requested USDA to allow alternative delivery for the projects. If approved, the District may utilize Construction Management at Risk as a project delivery method in place of Design Bid Build.

### **USDA Capital Program**

The District Treasurer continues to arrange for the interim financing needed to manage the initial cash flow related to the USDA Loan.

Work is ongoing to complete the required USDA paperwork.

EUSI staff are working to ensure that the District is prepared to move forward with the first phase projects as approved by the Board.

#### New Well and Water Production Infrastructure-

- Based upon the lowering water table issues with the existing wells, Aero Drilling will be available to discuss well improvement options.
- It may be necessary to accelerate the planning and design of a new deep well for the District.

# • Waterline Replacement and Design Engineering Services-

 There will be a recommendation of which engineers will be selected for each of the first phase projects at the next Board meeting.

### WIFA CAPITAL PROGRAM PLUS MISCELANEOUS DISTRICT CIP PROJECTS

  - Cool Pines Est Pipe Waterline Replacement Upgrade Phase B & C in Pine
    - We have requested a project update MGC contractors related to the project potholing and engineering design.
    - When the design is complete a final Task Order for the waterline installation will be developed and submitted to the Board for approval.

  - The final testing and engineering report will be submitted to ADEQ for the Approval of Construction.
